DW POPPY COMMUNITY THEMES...

Themes emerging from first DW Poppy community meeting:

- Community would like options (also at BSS consultation).
- Possible school closure?
- Impact on BCIT program at DW Poppy Secondary?
- Questions around feasibility of 6 to 12 at DW Poppy Secondary.
- Bussing implications of options?
- Funds for conversion (also at BSS consultation)?
- Benefits of K to 5 (also at BSS consultation)?
- Which community will proceed first with this model? Timeline of District implementation (also at BSS consultation)?



BROOKSWOOD COMMUNITY THEMES...

Themes emerging from first Brookswood community meeting:

- Impact on the secondary school if it becomes 9 to 12? Still viable at these numbers?
- What will be the potential catchment boundary changes associated with each option?
- Want to make sure that French Immersion is maintained.
- Impact on music program and daycare providers?
- Is the Fundamental Middle/Secondary site a possibility for Brookswood Middle?
- Is Glenwood elementary a possible school closure site if this process goes ahead?
- At this point not receptive to Brookswood secondary being converted to a 6 to 12 school.
